TOTAL MLS VOLUME FOR THE MONTH OF JUNE 2024

Net Closed Volume for the month of June, 2024 was \$330,728,321. There were 1,691 listings processed, 765 closed sales. Compared to last month, Net Closed Volume is down \$38,927,811. Listings are down 288, sales are down 56. Compared to last year, Net Closed Volume is down \$63,576,180. Listings are down 74, sales are down 119. Mandatory sales volume was \$313,527,077. Non-Mandatory sales volume was \$17,201,244. Pending sales (figured on list price) were \$468,807,242. There were 1075 pending sales processed.
