#### TOTAL MLS VOLUME FOR THE MONTH OF DECEMBER 2024

Net Closed Volume for the month of December 2024 was \$271,763,289. There were 656 listings processed. 585 closed sales. Compared to last month, Net Closed Volume is down \$6,969,031. Listings are down 318, sales are down 64. Compared to last year, Net Closed Volume is up \$46,129,159. Listings are down 2, sales are up 11. Mandatory sales volume was \$256,863,939. Non-Mandatory sales volume was \$14,899,350. Pending sales (figured on list price) were \$273,334,523. There were 626 pending sales processed.
